





(First party i.e. Association of Consulting Civil Engineers hereinafter shall be called as ACCE and second party i.e. Institute of Design Education and Architectural studies, Nagpur hereinafter referred as IDEAS)

To run the "TRAINING IN FIELD PRACTICES FOR STUDENTS OF ARCHITECTURE" certificate program for students of architecture at IDEAS, Nagpur
