I am directed to state that the Executive Committee of the Council of Architecture (COA considered the application form submitted by your institution, together with the information provided, for extension of approval of **Master of Architecture (M.Arch.) degree course**.

The Executive Committee, after consideration of the same, has decided to grant extension of approval to **Master of Architecture (Environmental Architecture) degree course** at your institution as under:

2-year Full-time Master of Architecture (Environmental Architecture) degree course	20	2022-2023

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2022-2023. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Executive Committee are mentioned below for your information and compliance:

- Institution must recruit 1 Associate Professor and 1 Assistant Professor (as per shortfall based on confirmed faculty in application) before the commencement of academic session.
- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms should be appointed/ maintained by the institution at all times.

The Council shall be at liberty to inspect the Institution at any point of time to assess the Minimum Standards of Architectural Education prescribed by the Council and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2022-2023, appropriate action shall be initiated against it.
